FREQUENTLY ASKED QUESTIONS

What is the cost to attend?

The cost to attend NAPCON26 depends on your membership or the timing of your registration:

- **Early Bird Member (thru January 30, 2026):** \$650
- **Standard Member (after January 30, 2026):** \$800
- **Non-Member:** \$900

An early bird rate will be available for members until January 30, 2026. Additionally, speakers will receive a registration rate equal to the early bird Member rate. An early bird rate is not available for non-members.

When will registration close?

Registration will remain open until sold out.

Will there be a virtual option?

No, there will not be virtual tickets to the conference.

Where is the conference taking place?

NAPCON26 will be in Riverside, California at the [Riverside Convention Center](#). Two hotel room blocks have been secured for this conference at nearby hotels. For more information about lodging, please refer to the "Lodging and Hotel" tab at the top of the [conference webpage](#).

Can I cancel my registration? What if I'm no longer able to attend?
